

Short-term study visa

The short-term study route allows non-EEA nationals to come to the UK to undertake a course of study that does not exceed 6 months.

- a) Nationals of the following countries are considered to be 'visa nationals' and are required to apply for a short-term study visa in advance of travelling to the UK:

- b) Nationals from countries not listed above are considered to be 'non-visa nationals' and entry to the UK can be requested under the short-term study route on arrival in the UK at the port of entry. Students will need to ensure they inform officials at Immigration Control that they are visiting the UK for study and show the acceptance letter issued by Capernwray for this purpose. There is no fee attached to entry at the border under this route.

*The following nationals can request entry to the UK under the short-term study route on arrival in the UK at the port of entry and are not required to apply for a visa in advance:

- a) nationals or citizens of the People's Republic of China who hold a passport issued by the Hong Kong Special Administrative Region;
- b) nationals or citizens of the People's Republic of China who hold a passport issued by the Macao Special Administrative Region;
- c) nationals or citizens of Taiwan who hold a passport issued by Taiwan that includes in it the number of the identification card issued by the competent authority in Taiwan;

Students will need to ensure they inform officials at Immigration Control that they are visiting the UK for study and show the acceptance letter issued by Capernwray for this purpose. There is no fee attached to entry at the border under this route.
